



- The Company is engaged solely in financial & investment activity segment and all activities of the Company revolve around this business. As such there are no other reportable segment as defined by Accounting Standard-17 on "Segment Reporting" issued by the Institute of Chartered Accountants of India.
- The Board of Director at their meeting proposed a dividend of Rs.1.2/- per share,subject to approval by Shareholders at the ensuing Annual General Meeting. In terms of revised Accounting Standard (AS) 4 'Contingencies and Events occurring after the Balance sheet date' as notified by the Ministry of Corporate Affairs through amendments to Companies (Accounting Standards) Amendment Rules, 2016, the Company has not appropriated proposed dividend (including tax) aggregating Rs. 1,34,86,593/- from the Statement of Profit and Loss for the year ended March 31, 2018.
- The figures of the 3 Months ended 31.3.2018 and corresponding 3 Months ended 31.03.2017 have been arrived at by deducting the published figures up to the 3rd Quarter ending 31.12.2017 and 31.12.2016 from the Audited figures of the respective financial years.
- Figures of the previous periods have been regrouped, wherever necessary, to correspond with the figures of the current period.
